




HALEY'S LOOP 287 SUBDIVISION NO. 2



NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

The undersigned, Cecil James Haley Jr., Trust, the Sean Haley Berry Trust, and Shaffer Funeral Home, LLC, do hereby adopt this plat approved subject to all planning ordinances, rules, regulations and resolutions of the City of Lufkin, Texas, and does hereby dedicate, in fee simple, to the public use forever, the streets and alleys shown. Herein, the streets and alleys are dedicated for street purposes. The easements and public use areas, as shown, are dedicated for the purpose of drainage, utility, water, gas, telephone, cable, and other purposes. Any structures or other improvements or growths shall be constructed or placed upon, over or across the easements as shown, except that landscape improvements may be placed in landscape easements, if approved by the City of Lufkin. In addition, utility easements may be placed in the easements as shown, except that utility companies shall have the right to remove and keep removed or to alter or change such easements, from time to time, for the purpose of growth which in any way interferes with the construction, maintenance or efficiency of their respective systems in and about the City of Lufkin and public utility entities shall at times have the full right of ingress and egress to or from their respective easements for the purpose of constructing, reconstructing, repairing, paving, maintaining, reading meters, and other acts of removing oil or gas or their respective systems without the necessity of any time preceding permission from anyone.
